Thanks to the generosity of our community, we once again exceeded our campaign goal by raising enough money to impact over 27,000 lives. Through our investments in area agencies focused on education, financial stability and health and safety, we are making progress in addressing our community's needs.

Financial investments are just one way we make an impact. 2012 saw exciting collaborations with local organizations focused on addressing the most basic needs. Whether it is providing free clothing to families, making sure children can participate in activities regardless of income, or addressing the health and well-being of our community, United Way continues to bring people together to address basic community needs.

In the area of volunteerism, United Way's Day of Caring grew so large in 2012 that we split it into two days. In the fall alone, 500 adult volunteers completed projects at local agencies and senior homes. We thank our local businesses for assembling teams and encouraging their employees to give back. Tallying both Day of Caring events, we expect over 1,000 volunteers will donate their time to projects throughout Muscatine- an incredible amount of support from a community of our size!

While our 2012 successes were exciting, we hope that 2013 will be even better as we focus on further developing community impact to strengthen the collective capacity of the people in the Greater Muscatine area to care for one another. In 2013, it will be the job of everyone in the community to continue to find new ways to come together to solve the problems that we face. United Way is proud to play an active role in that process.

### 2013 Campaign





### **2013 Community Investment**

Each year United Way of Muscatine recruits volunteers to participate on their Community Investment Committee. Teams review grant applications submitted by local agencies and determine how to invest the dollars raised for programs. Local agencies fill out detailed forms which include their budgets, program objectives, clients served, positive community impacts, methods used to measure outcomes and their strategic plan. After reviewing the grant applications, volunteers take a tour of the agency and hear a presentation about the program and its budget. The committee members then work together to determine which agencies should be funded and at what levels. The volunteers ensure that only local agencies that are effective and efficient are funded through United Way of Muscatine.



tary School students grades K-5 several online reading and math resources with 25 computers and provides adult volunteers and tutors to help with homework. Enrollment has steadily increased over the years to 85 students. Students at the Flickinger Learning Center are improving their Starr Matica math scores at a rate approaching 19% more than comparable non-Flickinger students and 10% in DIBELS raw words per minute reading abilities. On April 18th Flickinger will open a second location at Spring Valley Bible Camp serving Madison

Elementary School students living in Ripley's Affordable Housing. The new site already has 12 students signed up and they expect a need to start a waiting list. They plan to improve and expand the program at the second location in August with the start of the school year. Through the community's generous support, United Way of Muscatine was able to increase funding to Flickinger Learning Center and help support the expansion of their services.

# Muscatine

Funded Program Spotlight: Phyllis had been trying repeatedly to get Social Legal Services Security Disability benefits for the past 10 years. She had worked at a factory, Hardee's, West Side Convenience Store and Hy Vee Store. After numerous surgeries and a variety of major health issues she could no longer work full-time. Phyllis went to

Muscatine Legal Services for assistance. Muscatine Legal Services is able to offer discounted legal service based on income, because of funding they receive from United Way of Muscatine. After a two year wait, in which her file was prepared for the administrative law judge, a hearing was finally held and Phyllis prevailed. In Phyllis' own words, she stated that "If it wasn't for all the work Muscatine Legal Service did for me, I think I would have been turned down again. I am so thankful for them."

Funded Program Spotlight: Sarah had her daughter when she was 17. Her daughter was born with a double cleft palate and will require numerous surgeries. She has had 2 surgeries already and come through well and she is on track developmentally. The HOPES program has been working with Sarah since she was prenatal. In that time, they walked through the shock of learning that her baby would be born with a double cleft palate, a sporadically supportive father of the baby, having a baby, caring for the baby, returning to school and

learning to manage time in a new way. They are now working with her to learn what to expect developmentally as her daughter nears 2 years old. Sarah has shared that HOPES has given her a larger support system, someone she can trust to talk to about being a mom, support in making changes or starting new habits, trustworthy information and respectful teaching about safety, health, nutrition, and discipline. Sarah also enjoys the developmental activities that they bring to the home each visit that help her expand how she interacts and plays with her daughter. In addition, Sarah loves the group activities that HOPES hosts throughout the year because they give her a chance to socialize with other parents, do fun activities, and share an experience with her daughter. Sarah is truly a success story because she kept her baby with special needs, returned to high school after the birth, has maintained part time work, has obtained her CNA certificate, has goals for the future that include college, and is well bonded with and visibly cares for and loves her daughter. The LSI HOPES program's continued funding from United Way of Muscatine ensures that area families that need help are supported and that children have a healthy start in life

### **Local Information -N- Connection to Services (LINCS)**

United Way's LINCS (Local Information –N- Connection to Services) program connects people in need with the programs and services that can best help them. In this way, the LINCS program brings agencies together to collaborate on how to best serve the Muscatine community. The program also keeps area agencies notified about changes with service providers and programs throughout the community through a monthly newsletter.



In its role as collaborator and coordinator, the program has served as a point of contact for several area funds and services:

The Almoner Fund – The Almoner Fund is a fund supported by local churches and private donors. It is used to pay for things that Muscatine County money can't assist with such as rent or utility deposits or work shoes. The main use of the fund is to help Muscatine County Community Services consumers to be more self-sufficient by assisting them to obtain housing or items necessary for employment. Through its administration of the Almoner Fund, the LINCS program provided \$18,748.28 to assist 120 families in 2012.

The Kids First Fund – Started in 2009, the Kids First Fund helps Muscatine students be involved in activities by paying for activity registration fees or equipment. The fund also helps students be successful in the classroom by paying for anything that will eliminate barriers to learning. The Kids First Fund has paid for everything from softball and baseball registration and

soccer equipment to school supplies and ACT testing fees. In 2012, the Kids First Fund provided \$11,950.54 to help 200 students. The major fundraisers for this fund are an annual Vintner's Dinner and quarterly pancake breakfast.

**Goodwill Vouchers** – Through a partnership with Goodwill of the Heartland, the LINCS program has access to clothing vouchers for use at Goodwill stores. These vouchers allow families who couldn't otherwise afford season-appropriate clothing to be appropriately dressed for the weather. In 2012, the LINCS program distributed \$3,170 worth of vouchers to 105 families in need.



Muscatine Housing Cluster – State housing dollars are brought in to the Muscatine community each year through the Muscatine Housing Cluster to help with housing related needs for low-income residents. These funds are used to subsidize emergency home repair, provide first-time home buyers with down payment assistance or to help pay for staffing for housing related programs. As the fiscal agent for the Muscatine Housing Cluster, the United Way distributed \$75,978.60 in 2012 to help 417 families in Muscatine County.

Muscatine Louisa Disaster Recovery Committee — As the center for disaster recovery in Muscatine and Louisa County for the floods of 2008, United Way provided case management and access to state disaster funds and private donations to help clients in the recovery process. This work came to a close in 2011. As fiscal agent, United Way accessed \$918,515.47 to assist 133 clients with financial help to recover from this federally declared disaster. Hundreds more received case management assistance to put them in touch with other agencies or resources. Should another natural disaster occur, United Way of Muscatine has the framework in place to to address the community's needs.

### **Muscatine Community Volunteer Solutions**

The Volunteer Solutions Center has had a great year serving the volunteer needs of the Muscatine community. We continue to work to match community members to appropriate volunteer opportunities. With so many great agencies in our community being understaffed and underfunded, volunteers play a crucial role in helping them work towards their mission.



We continue to maintain our website, www.volunteermuscatine.org, to make it easy for Muscatine residents to connect with community agencies and their volunteer opportunities. Agencies can post their volunteer opportunities on the website throughout the year, updating them as they change. Volunteers are then able to search for opportunities based on their preferences and contact the agency directly from the website. Volunteermuscatine.org makes it easy for everyone to find a volunteer opportunity that fits their skills, schedules and passions!



Nite at the Races was a fundraiser for United Way's LINCS and Volunteer Solutions programs. The event featured video horse races on the big screen and allowed guests to bet "funny money" on the horse they thought would win each race. Guests also had the opportunity to bid in a silent auction and to purchase raffle tickets. Last year's event had 136 attendees and raised \$7,560.



On September 19, 2012, United Way hosted the 6th annual **Day of Caring**. As a result of the tremendous growth in participation the Day of Caring has seen in the past five years, this year the United Way will be hosting two separate Day of Caring events. In addition to the annual fall event for adults, a second day will be added in spring 2013 specifically for students. Over 500 people participated in 49 service projects across the Muscatine

community for the Fall 2012 Day of Caring. Volunteers worked with non-profit agencies such as Flickinger Learning Center, the Domestic Violence Shelter, MCSA, and Senior Resources, helped clean up city parks, and worked on multiple senior homes. Spring Day of Caring with students will be April 26th.



### **Let's Talk Affinity Groups**

#### **Family Effectiveness Coalition of Muscatine County:**

The 4th year of "Summer Things to Do" flier was shared with K-5th grade families and community organizations. The 2nd Year of "Plug Into Your Family" Week was organized with 13 organizations hosting events that week. This event encourages families to turn off electronics and connect with their family. The 1st Year of the "Winter Things to Do" Flier, was shared with K-5 grade families and community organizations. Resource sharing is done at every monthly meeting.

#### **Youth Affinity Group:**

Mission- "Working Better Together for Youth in Muscatine":

- Introduce a strength based approach for promoting youth development
- Promote and facilitate communication among youth and adults
- Educate and engage our community on the importance of everyone's role in the lives of children and youth



Time this past year was spent looking at various models that would support this work. Historically the group has used the 40 Developmental Assets as a foundation. The Ready by 21 model was explored and although firmly supported by members, it was determined that the infrastructure needed to employ the model could not be implemented via Youth Affinity. However, some of the tools and resources provided may be used in future endeavors.

Youth Affinity is also an opportunity for youth serving organizations to network and share information and will continue to serve this purpose that allows for partnerships and collaboration on projects. This group is an opportunity for agencies to support each other professionally and *Parent, Teacher, Mentor, Friend* by Peter Benson (founder of Search Institute) was discussed as a way to affirm their work and provide simple steps to adopt.

One tool the group thought would be helpful in bridging community communication and efforts was the community mapping tool/process as used by Ready by 21.



Krista Regennitter presented at the school district as a way to introduce the group, mission, and foundation of the 40 Developmental Assets and how the group might better work in partnership with the school district.

As a result, the district has asked that Youth Affinity work with them in finding ways to enhance and support the skills students in the District are building from the "Leader in Me" model. The group is currently strategizing ways to do just that, including an informational session in April 2013.
